#### Welcome to Melanoma Land!

You won't find this caption displayed anytime soon on Florida tourism posters but summer is here and so are more of the damaging ultraviolet rays that promote skin cancer. Although sun-worshipers might beg to differ, there is no question that the Florida sunshine should be consumed in moderation.

Why the concern about sun exposure? In one word – melanoma. Of all types of skin cancer, melanoma is the most feared. If the diagnosis is delayed, melanoma has the potential to spread to distant sites and can be deadly. More that 44,000 people are diagnosed with melanoma every year in the United States and the rates have more than doubled over the last 20 years.

Melanoma is largely preventable because most cases are related to excessive sunlight exposure. People with fair skin and freckles are at higher risk, but melanoma can occur in anyone. The basic principles of prevention include limitation of sun exposure during peak UV hours (10am to 4pm), regular use of sunblock with sun protection factor (SPF) of 15 to 30, and use of sunglasses and wide-brimmed hats.

Despite our best intentions, melanoma is not always preventable. Studies have shown that risk of melanoma may actually be most closely related to sun exposure and sunburns that occur during practice in Vero Beach, Florida childhood. We can't go back since 1990. The hallmarks of melanoma are a dark spot on the skin which has irregular borders, variable color, size more than 6mm, and is asymmetric. Rapid growth in size is also worrisome. Since it may be difficult for even an experienced doctor to identify melanoma correctly it may be best for those at higher risk to see a dermatologist for regular skin examinations. Some people are at much higher risk of melanoma because of family history and may benefit from regular skin examinations and total body skin photography.

One must keep the risks of excessive sun exposure in perspective. After all, many of us chose to live in Florida precisely because we enjoy sunshine, water sports and activities. The key is moderation and sensible precautions, then go ahead and catch those rays.

practice in Vero Beach, Florida since 1990. He specializes in the treatment of HIV and hepatitis C, and is actively involved in research. He is also the founder and medical director of the AIDS Research and Treatment Center of the Treasure Coast, a not-for-profit HIV clinic located in Ft. Pierce, Florida. #### NSU Scholarship Promotes Tolerance Florida

It was a parent's wish to honor her son Gordon's life that led Eve Rose to establish a scholarship at Nova Southeastern University (NSU)'s Center for Psychological Studies this year in order to promote tolerance and understanding of gays and lesbians in South Florida.

The creation of the scholarship highlights how the psychological establishment's view of homosexuality has changed dramatically in recent years. Just three decades ago, psychiatrists and the scientific community defined homosexuality as a human mental illness—something to be cured, not tolerated. Not until the burgeoning social pressure of the gay rights movement demanded change in how Americans viewed and categorized gays and lesbians did the country's mental healthcare workers surrender their focus on unsuccessful treatment and correction and move the nation instead toward understanding, social acceptance and tolerance.

The A. Gordon Rose Scholarship: Another View is the result of a \$100,000 gift by the Hollywood, Florida-based family. Gordon Rose, 56, who was the driving force behind the development of the Tanglewood Music Festival, never told his mother that he was gay.

On Monday, July 14 two cousins in Boca Raton Adam Gleicher and his cousin, Ed Loomis, said they were waiting in line at the Blockbuster store at 7056 Beracasa Way when a woman behind them became impatient. According to Gleicher, the woman started yelling anti-gay epithets at them, followed them out to the parking lot and assaulted Gleicher with a videotape box.

The altercation began when Loomis inquired about a problem with his account. According to Loomis, while

he was discussing the situation with the clerk, the woman behind them said, "I'm a patient woman, but you're not opening a bank account." She then explained that her dog was in the car.


Gleicher told her that she shouldn't leave her dog in the car because it's against the law. According to Gleicher, the woman became progressively ruder and more impatient.

"While we were walking out to the car, she had more to say," Gleicher said. "She got really nasty and called us 'faggots," According to Gleicher, the woman said, "Go home and watch your movies, homos." Loomis said the woman also said, "I hate faggots."

Gleicher, who is heterosexual and married with children, then showed her his wedding ring. But the woman was apparently unimpressed. "She said, 'Oh, so you've got your gay lover with you, faggot," Gleicher said.

"I guess seeing two guys at the video store, she just assumed we were both gay," Gleicher said. "She made it very apparent that she did not like homosexuals, because that's all that kept coming out of her mouth."

As they were trying to leave, Gleicher said the woman hit him on the shoulder and left leg with the videotape box she was carrying. "She







wouldn't go away," Gleicher said. "She kept yelling at the two of us and using the same terminology. I told Ed, 'Get in the car, we're leaving."" I never threatened her in any way. She stood behind the car and said, "You're not going anywhere."

Eventually the woman left, and Gleicher and Loomis went home.

Gleicher filed a report with the Palm Beach County Sheriff's Office. According to the report, titled Case No. 03089951, "attempts were made to locate and identify the female, but were unsuccessful."

The report describes the "verbal altercation" and Gleicher's allegation that he was hit with the video box, but it does not include any of the antigay language that Gleicher recounted.

Julie Ann, a clerk at the Blockbuster store, only witnessed part of the altercation, but she corroborated much of what Gleicher said. "I was having a conversation [with Loomis], and she got really impatient," Julie Ann said. "I was like, 'Ma'am, don't start a fight. I heard her screaming at them. She shouted something at them as she walked out the door." Julie Ann said she didn't witness the incident in the parking lot.

"I've been discriminated against in my past job, and I never really did anything about it," said Loomis, who is openly gay. "But this time, I wanted to do something about it."

Now that filming has wrapped and the show is set to debut Tuesday, July 29, James is speaking out about the ruse.

"I felt betrayed," the California executive told Newsweek magazine. James wasn't told that some of his suitors were straight until he narrowed his choices to three men. "They told me they put a twist in there because they wanted straight people to watch," he says. "I said to them, 'Well, you've played gay people as entertainment for straight people. Of course they're going to watch.""

The Lance Armstrong Foundation, founded by cancer survivor and Tour de France champion Lance Armstrong, will give a grant of \$5,000 to the Mautner Project for Lesbians With Cancer to support the organization's lesbian cancer survivorship program. The grant, which was announced July 14, is the first ever given by the foundation to a gay or lesbian health group. "The Lance Armstrong Foundation works to promote all areas of cancer survivorship," said Douglas Ulman, the foundation's director of survivorship, in a press release announcing the grant. "Through our partnerships with dedicated organizations like the Mautner Project, we will continue to enhance the quality of life for cancer survivors everywhere."

The Armstrong Foundation works to promote the optimal physical, psychological and social recovery and care of cancer survivors and their loved ones.

"We are proud to partner with [the foundation in its] quest to improve the quality of life for all cancer survivors and their families regardless of their sexual or gender orientation," said Mautner Executive Director Kathleen DeBold. "The Lance Armstrong Foundation knows that although doctors, researchers and insurance companies may discriminate against LGBT people, cancer does not."

Founded in 1990, the Mautner Project provides education, support and services to women who are living with a cancer diagnosis, caring for a partner or family member with a cancer or coping with the loss of a loved one. The project also provides programming, training and technical assistance to local groups seeking to improve lesbian health.
