

# Spiritually Speaking

## Reflection or Deflection?

I was recently reading an article from the Huffington Press (great source of insight at times) and I was reminded that sin is sin. What defines sin is that it is an act that harms others and ultimately us. If a person steals, lies, commits adultery, kills, or any number of other acts, they have harmed someone else. I also believe they have harmed themselves because each time we willfully choose to do the wrong thing; we build a layer over our God-given conscience. This conscience is what is supposed to separate us from the animals in this world. When a lion kills an antelope, the lion has no remorse. Yet, when a man kills another man, he is supposed to feel that "tug" to his heart telling him that what he is doing is wrong. This has been depicted in cartoons as having the devil on one shoulder and an angel on the other. These two figures debate the issue with the human in the middle but ultimately, the human is the one who chooses. The days of, "the devil made me do it" are long passed. That was a cute slogan but held very little truth as each of us has free will to choose our behavior.

Let's get back to the idea of sin as promised the beginning of this article. Is homosexuality a sin? Well, if you look at the definition I gave at the beginning, an act that harms others, being gay does not fit at all. When two people love each other, where's the harm if they happen to be of the same sex? They have not harmed anyone else or themselves by their relationship. The Bible talks a lot more about love than it does anything

else, even sin. There are several types of love spoken of in scripture that relate to our love for each other: the first type is erotic love – sexual attraction; the 2<sup>nd</sup> is friendship - mutual affection; and the 3<sup>rd</sup> type is love in action - charity. All of these are between consenting humans and none of these are sin as long as another isn't harmed in the process (look out for the first one!). These are the same whether the people are gay or straight, there is no sexual orientation mentioned.

So why do those in the "straight Christian" world spend so much time and effort condemning our life-style? Look back at the title of this article and you may see where I am heading with this – Reflection or Deflection? Reflection is defined by the Encarta Dictionary as 1) the image that appears in a mirror; 2) careful thought, reconsidering previous actions, events, or decisions; 3) the result of something; 4) a cause of blame or credit to somebody or something. Deflection is defined by this same dictionary as 1) a change of course that results from hitting someone or something; 2) the act of directing people's attention or criticism away from something or someone; 3) a definite movement of the indicator on a measuring instrument. Well, well, well! Let's look at this a little more carefully. Reflection - a cause of blame or credit to somebody; deflection – the act of directing people's attention or criticism away from somebody. I wonder if by making such a big thing out of the homosexual issue and Christianity, "they" are trying to get the attention off of their own sin and shortcomings and place the blame for the ills of the world

on us! This seems rather simple in light of the fact that our relationships do no harm to others and thus do not meet the criteria as sin. I wonder what sins these folks are trying to deflect. Are they afraid to see themselves reflected in the mirror of homosexuality? Are they closet gays without the courage of their basic instincts? How would those that make such a big deal about Gay Christians fare if the microscope were trained on their lives as it is so often on ours? Would they still look as holy as they think they do now? How about the Churches? Would those ministries stand the scrutiny we face daily?

As a female, lesbian clergyperson, I face criticism of my lifestyle in "mainstream" religious circles for several reasons but if Jesus were to speak to the Church today, His parable might be about love and everyone's right to experience it, regardless of sexual orientation.

So, the next time you feel you are

being judged because of your sexual orientation, take a moment to pray for the person(s) doing the judging because this is what Jesus would have done.

## Scape-goating the Immigrant

Very recently I was reading the local newspaper and saw the Florida County in which I live was being referred to as “the reddest county in the United States.” This, of course, was a reference to the very Conservative politics of those living here. Many of those living here are so Republican they make Dick Cheney seem like a pinko Commie tool. This area is also known for the deeply Fundamentalist bent their version of Christianity has taken. The area is densely populated with Fundamentalist and Evangelical Christian Churches.

Still, last week, after the Post Office drive for non-perishable food items, several people were front and center on the local news red-faced and livid, declaiming the food drive and swearing that they will never give to that drive again after what was done with a portion of the food. And what, you might ask, was the sin committed by those who administered the Drive? It’s quite simple really. It seems a portion of the foodstuffs went to a local social service group that administers to the poor without checking for citizenship. It seems that this group has given food to people who had none, even if these people did not hold a green card. I am sorry to say that they might have given some food to hungry people who are, in the vernacular of the day, “illegals..”

I guess when Christ admonished his followers to feed the hungry he had a hidden meaning, or there were words that didn’t get transcribed. I think what Christ meant to say was “Feed the

hungry as long as they have their papers making them legal residents, and should they not have those papers... let them and their children starve.” Yes, I am sure that is what he meant to say.

This is the second time in recent weeks that I have become angry and dismayed at what I hear. I had this same feeling when some of the same people fought the recent Health Care Legislation, and the reason I heard was that health care would then be available to these “illegals.” Oh my... can you believe for a moment that MY MONEY WILL BE USED TO PROVIDE MEDICAL CARE FOR THESE AWFUL PEOPLE WHO HAVE INVADED OUR COUNTRY?” Well, I have news for those who have that fear. The provision of emergency health care paid for by the state has long been in place for those who seek care in our hospital emergency rooms. The alternative would be to let them die in the gutter outside of the hospitals. I would ask everyone in favor of that alternative to raise their hands, and to show up with their shovels so we can bury them and their children. What is wrong with this society? When have we become so selfish that we cannot see the contradiction between what we profess to believe, and how we behave?

Immigrants. Illegals. We, a nation of immigrants have vilified both of these words and made them these people objects of fear and for some of loathing. Whenever a group is held up to ridicule and made scapegoat for situations in society over which they have no control it can lead to violence being

perpetrated against its members, and witch hunts perpetrated against those who might have a kind word for them.

During the Second World War, we saw what happened to Japanese Americans, then, after the war the demagogue who was Senator Joseph McCarthy painted anyone whom he disliked, and anyone who disagreed with him as a “Red” and in so doing he ruined careers, families, caused suicides and left untold damage in his wake. When he was finally subdued, the Communist Menace was still the monster and it was to fight this monster that the Ultra Right Wing and the Fundamentalist Religions raised their monies. “Fight the Menace.” The problem is, when Communism fell, a new monster was needed to keep the cash flowing in.

That new monster came to The Jerry Falwells, the Pat Robertson’s, The Family Research Council and the conservative branch of the Republican Party in the guise of the gay and lesbian population that seemed to be alive and well in most regions of the country. The plea from the money grabbers still resounds with “Send us your money so we can stop these queers from coming in and stealing your children and seducing them into their lives of depravity. We all know they cannot reproduce their kind, so how else will they grow?” People fell for that one hook, line and sinker, and so screaming about the gays among us became the cash cow for these groups.

Now gay people have been joined by immigrants and “illegals.” The thing is, all the arguments used to justify the enmity against this new group are just as full of holes as those used against any group that came before them: They are causing the crime rate to increase. Studies have proven otherwise; they are taking jobs away from good Americans. How many “good” Americans are in line



for the lowest paying food industry jobs or for the lowest paying menial labor out there? How many “good” Americans are looking for less than minimum wages to work in the home of a wealthy person and live with the fear of discovery, or of being reported if they step out of line. How many? This scapegoated group also has to worry about losing their children, as there is a drive among “good” Americans to separate children who are citizens from their parents who are not. There is also a drive from another group to revoke the citizenship of children who legally hold it so that they can be sent to where? Anywhere but here. Where is compassion, and where is the justice.





TAMPA—Equality Florida applauds the Hillsborough County School Board for their unanimous June 15th vote to add gender identity to the Nondiscrimination and Equal Employment Policy for Hillsborough County Public Schools.

Sexual orientation protections were already included in the Hillsborough policy. With this vote, Hillsborough schools now offer fully inclusive protection to the 207,549 students who make up the 3rd largest school district in Florida.

Currently, 64% of Florida students attend schools that ban anti-gay bullying, while 44% attend schools that prohibit harassment based on both sexual orientation and gender identity.

"Equality Florida has worked with school districts across the state to enact strong, fully inclusive non-discrimination and anti-bullying policies," said Nadine Smith, Equality Florida's executive director. "Over the past five months, Equality Florida leaders and community allies have met with Hillsborough school board members to educate them on the importance of a fully inclusive policy," said Smith "The addition of these critical protections, which passed without opposition, are a huge step forward for both students and district employees alike."

Special thanks to Hillsborough County School Board member April Griffin, who led the effort on the board.

"With this vote, Hillsborough County Public Schools institutes a common sense non-discrimination policy that sets a standard of safety and respect for all students, staff and faculty. I am proud to have sponsored this positive change in our district culture. I look forward to continue championing tolerance and civility in our community." — April Griffin, Hillsborough County School Board Member

FT. MEYERS—As reported in the News-Press, twelve Lee County jurors rejected the testimony of Anibal Mayor, who told them he felt like he was going to be sexually assaulted as his justification for choking and stabbing Dean Blietz to death in July 2008.

The jury guaranteed that 28-year-old Mayor will go back to prison, this time for the rest of his life when he is sentenced this fall. Jurors found him guilty of first-degree murder and armed robbery.

Blietz was found stabbed to death in his Fairview Avenue home July 2, 2008. Mayor told police he killed Blietz, who took in ex-convicts such as Mayor to help them readjust to society, over \$130 to buy cocaine.

On the stand, Mayor told jurors Blietz once exposed himself, and on a different occasion, touched his thigh, telling him he had to "take it one day at a time." He also told of being raped by four men in prison.

Mayor's attorney, in closing arguments, told jurors that the sexual advances re-sparked a fear Mayor had after the prison rape.

But when Mayor gave a voluntary statement to police, he didn't tell them about the alleged sexual advances and he wasn't under arrest when he confessed, describing the murder in graphic detail.

Assistant state attorney Bob Lee told jurors before they began deliberations that Mayor's story was bogus, concocted after years in custody. Lee cited 10 examples why the testimony didn't make sense.

"Does this sound like the description of someone who's afraid of Mr. Dean because he was coming on to him sexually?" Lee asked, rhetorically. "Of course not. I encourage you to use your good common sense."

DETROIT—Queerty.com reported this quote: "I think if two people love each other, then what the hell? I think that everyone should have the chance to be equally miserable, if they want. ... It's the new tolerant me! — Eminem, the 37-year-old rapper, has a new record out and a new way of thinking about same-sex marriage.

And it officially makes his views on the subject more forward-thinking than his one-time stage partner Elton John, who insisted, "If gay people want to get married, or get together, they should have a civil partnership."

WASHINGTON, DC—Citing a posting on the DOJ web site, the New York Times reported that the Justice Department has decided that federal prosecutors should enforce criminal provisions in the Violence Against Women Act in cases involving gay and lesbian relationships

In a seven-page legal analysis, David J. Barron, the acting assistant attorney general of the Justice Department's Office of Legal Counsel, concluded that federal prosecutors may use the law in cases of interstate stalking and domestic violence regardless of whether the victim or the defendant is a man or a woman.

"The text, relevant case law and legislative history all support the conclusion" that the law's criminal provisions "apply when the offender and the victim are the same sex," Mr. Barron wrote.

A Justice Department spokeswoman, said that the office's conclusion had been sent as guidance to federal prosecutors around the country.

Congress first passed the Violence

Against Women Act in 1994. Among other things, its provisions made it a federal crime to cross state lines with the intent of committing domestic violence, stalking, or violating a protection order. Lawmakers have since expanded the act several times.

The federal government's treatment of gay and lesbian relationships has been a matter of sharp dispute in view of the 1996 Defense of Marriage Act which requires the federal government to define legal terms like "marriage" and "spouse" as categories that can exist only with a union between one man and one woman.

Mr. Barron points out that although the Violence Against Women Act defines possible victims as including the "spouse" of the abuser, the act also includes terms not covered by the Defense of Marriage Act, like "dating partner" and "intimate partner."

Moreover, he noted, the text of the act uses gender-neutral language, like saying "another person" instead of "a woman." He cited such language as proof that Congress intended the protections to cover same-sex couples as well as heterosexual ones.

"It is true that the statute is entitled the Violence Against Women Act, but other provisions of the Act make clear it applies to conduct perpetrated against male, as well as female, victims," Mr. Barron wrote.

WASHINGTON, DC—The Washington Post reported that President Obama, on June 3, extended a wider range of benefits to the same-sex partners of eligible federal workers, including access to medical treatment, relocation assistance, credit unions and fitness centers.

The move goes beyond a memo Obama signed last June, which permitted same-sex partners to use the government's long-term-care insurance and other fringe benefits. Same-sex partners become eligible for such insurance in July.

Last year Obama ordered federal agencies to identify benefits that could be offered to same-sex partners and it was determined that at least some agencies could also permit credit union and gym memberships, access to counseling services, adoption counseling, and agency events or outings.

A limited number of intelligence and financial regulatory agencies, Obama's memo said, will be able to provide reimbursements for health-insurance premiums, dental and vision insurance, business travel accident insurance and tax reimbursements for gym memberships, physical exams and homeowners' insurance.

These benefits do not cover uniformed members of the military.

Though Obama has extended a greater number of benefits to gay federal workers than any of his predecessors, he is prevented by federal law from providing full benefits to same-sex partners. To that end, he reiterated support for House and Senate legislation that would grant all federal benefits to same-sex partners.

DES MOINES—The edgeNewEngland reported that a GOP leader issued a threat to gay prospective 2012 candidate.

Fred Karger is a Republican who has worked with the GOP for four decades as a political consultant; he's now mulling a run for the White House in 2012. The sticking point for some of Karger's fellow Republicans is that Karger is an openly gay political activist.

Though Karger says he has been "graciously" received by GOP leading lights such as Michael Steele, his potential candidacy drew the ire of at least one fellow Republican. Iowa Republican National Committeeman Steve Scheffler fired off an email to Karger in which he threatened to do everything he can in order to "abort" Karger's political prospects in 2012, reported local newspaper the Des Moines Register on May 27.

"You and the radical homosexual community

want to harass supporters of REAL marriage," Scheffler emailed Karger, going on to vow, "I will work overtime to help ensure that your political aspirations are aborted right here in Iowa."

The email was a response to a message sent out by Karger's group detailing how anti-gay group the National Organization for Marriage had lost a case in court to keep its donor lists away from the scrutiny of state election officials in Maine, following NOM's contribution of about \$2 million to a successful voter initiative in that state to repeal a law that would have allowed gay and lesbian Maine families to wed.

A similar campaign mounted by NOM in Iowa also resulted in state election officials demanding the anti-gay group's donor lists. An appeal by NOM was defeated in a District 1 federal court.

Karger had also registered a complaint against the Mormon Church for its role in the 2008 anti-gay ballot initiative Proposition 8, which Karger said the Mormons financed far in excess of the \$2,000 the church initially claimed. An investigation by the The California Fair Political Practices Commission led to a fine of more than \$5,000 against the Mormon Church.

"I'm not going to get involved in the presidential caucuses but I'm going to call a spade a spade," Scheffler, who is also president of the Iowa Christian Alliance, told the press following the email. "When you have somebody who is this far out of the mainstream of the political party, I'm just going to tell them what I think."

ELK GROVE VILLAGE—A nearly 25-year study concluded that children raised in lesbian households were psychologically well-adjusted and had fewer behavioral problems than their peers.

The study, published in the journal Pediatrics, followed 78 lesbian couples who conceived through sperm donations and assessed their children's well-being through a series of questionnaires and interviews.

Funding for the research came from several lesbian, gay, bisexual, and transgender advocacy groups, such as the Gill Foundation and the Lesbian Health Fund from the Gay Lesbian Medical Association.


